Read about the *Coinbase, Inc. v. Abraham Bielski* case now pending in the U.S. Supreme Court. The question presented

per the Court's docket is:

Under § 16(a) of the Federal Arbitration Act, when a district court denies a motion to compel arbitration, the party seeking arbitration may file an immediate interlocutory appeal. This Court has held that an appeal "divests the district court of its control over those aspects of the case involved in the appeal." *Griggs v. Provident Consumer Disc. Co.*, 459 U.S. 56, 58 (1982) (per curiam). The question presented is: Does a non-frivolous appeal of the denial of a motion to compel arbitration oust a district court's jurisdiction to proceed with litigation pending appeal, as the Third, Fourth, Seventh, Tenth, Eleventh and D.C. Circuits have held, or does the district court retain discretion to proceed with litigation while the appeal is pending, as the Second, Fifth, and Ninth Circuits have held?

All briefs are available on the U.S. Supreme Court docket and can be accessedhere.

John's book explains his view that that "silent" awards are not less prone to challenge and not necessarily cheaper to prepare than reasoned awards, criticizes six ways awards often fail to give meaningful reasons, and argues that U.S. courts have improperly tended to uphold such awards as "reasoned." The work has John's extensive analysis of each ground of vacatur and its success rate based on his study of vacatur opinions in Westlaw for 2010–2017 with a link to appendices with synopses of the vacatur opinions for exceeding powers, manifest disregard, violating public policy, and evident partiality. It also has appendices for awards he treats as well reasoned and for those he views as not so. John will be speaking on awards at the upcoming NAB Members Retreat in Santa Fe in April.

#### Hon. Charles N. Brower (Chevy Chase, MD; The Hague; London)

Charles Brower became The Acting Legal Adviser of the State Department for months at the end of four years in that office; has been a Judge of the Iran–United States Claims Tribunal for 40 years; is the most appointed of the only five Americans to serve as Judge ad hoc of the International Court of Justice; has served as Judge ad hoc of the Inter-American Court of Human Rights; served in the White House as sub–Cabinet Deputy Special Counsellor to President Reagan dealing with the Iran–Contra affair; has been an Arbitrator Member of Twenty Essex Chambers in London since 2001; and spent 34 years as associate, partner and special counsel of White & Case

LLP for 30 years in New York and Washington, D.C. His memoirs, "JUDGING IRAN - A Memoir of The Hague, The White House, and Life on the Front Line of International Justice," are available on Amazon.



#### Michael S. Goldberg (Houston, TX and New York, NY)

Michael Goldberg, FCIArb, specializes in international arbitration and disputes in Baker Botts' Houston and New York offices. Michael has handled arbitrations both as arbitrator and as counsel throughout the world and within most arbitral institutions. Among his honors, he was inducted into the initial Legal 500 Hall of Fame for international arbitration, was recognized as a Trailblazer for White Collar Litigation by the National Law Journal and was presented the Light of Justice in Action Award by the Texas

Defender Service. He has served as Chairman of Holocaust Museum Houston and as General Counsel for various sports teams, including the Houston Rockets. Michael is also an adjunct professor of international arbitration at the University of Texas School of Law. Michael graduated Magna Cum Laude and Phi Beta Kappa from Rice University and with honors from the University of Texas School of Law.
