Out of respect for the teams not in the Super Bowl, I will conclude by simply wishing that the referees get it right for a fair game!

Read about the **Compañía de Inversiones Mercantiles S.A. v. Grupo Cementos de Chihuahua S.A.B. de C.V.** case recently published by the U.S. Court of Appeals for the Tenth Circuit.

The above case may be quite interesting. It involves a Rule 60(b) motion to overturn a judgment confirming an arbitration award based on a subsequent vacatur in the country (Bolivia) that was the seat of arbitration. The Tenth Circuit MAY balance against comity considerations (1) whether the annulment is repugnant to U.S. public policy OR (2) whether giving effect to the annulment would undermine U.S. public policy. Because the District Court did not abuse its discretion by refusing to vacate its confirmation judgment, the Tenth Circuit affirmed. The case is a split decision with the dissent suggestion that there is now a circuit split (which the majority denies). My guess is that the loser will seek Supreme Court Certiorari. Stay tuned. John McArthur FCI Arb and Northern California Chapter Chair has written a new, scholarly book, *The Reasoned Arbitration Award in the United States: Its Promise, Problems, Preparation, and Preservation*. John's book explains his view that that "silent" awards are not less prone to challenge and not necessarily cheaper to prepare than reasoned awards, criticizes six ways awards often fail to give meaningful reasons, and argues that U.S. courts have improperly tended to uphold such awards as "reasoned." The work has John's extensive analysis of each ground of vacatur and its success rate based on his study of vacatur opinions in Westlaw for 2010–2017 with a link to appendices with synopses of the vacatur opinions for exceeding powers, manifest disregard, violating public policy, and evident partiality. It also has appendices for awards he treats as well reasoned and for those he views as not so. John will be speaking on awards at the upcoming NAB Members Retreat in Santa Fe in April.

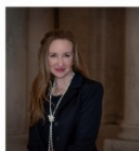
