**Trustee's Report by Amb. (r.) David Huebner, FCIArb, C.Arb, CollArb**



CIArb colleagues, I am the regional trustee for the Americas on the Chartered Institute's global board of trustees ("BoT"). NAB's newsletter editor has invited me to provide an update on BoT activity in recent months, which follows:

**Charter/By-Law Changes.** At last autumn's CIArb global annual general membership meeting ("AGM"), members present (by Zoom) approved a package of proposed changes to the Institute's Royal Charter and Bye-Laws proposed by BoT. Under the terms of our Royal Charter, such changes can only take effect if approved by the King. We submitted the package to the Privy Counsel shortly after the AGM. In February we were advised that King Charles had signed the necessary order.

The package approved by the King comprised a variety of changes to our governing docs, including the following which I believe are particularly important: (1) five "appointed" trustee slots were added to the board of trustees (all trustees are currently elected regionally, including our 1 trustee slot in the Americas), which will allow BoT to recruit candidates from any jurisdiction with diverse backgrounds and expertise (including in management, finance, restructuring, consulting, etc.) of use to Institute governance; (2) new Governance and Nominations Committees of the board were formed; and (3) a number of structures/functions/requirements were moved from the

Charter and By-Laws (which require Royal assent to change) into the Institute's Regulations (which can now be revised by the BoT any time).

This has been a major focus during my time on BoT, and I believe that the changes and new flexibility will facilitate and accelerate necessary change in the Institute to make us more efficient, effective, responsive, inclusive, and successful. We have already taken long-overdue steps using the new flexibility.

**My Role on BoT.** The trustee position requires, on average, 10 to 12 hours of my time each week, which increases significantly in the immediate run-up to each of the 4 BoT meetings each year.

I spent the past two years as the Institute's treasurer and chair of the BoT's Audit & Risk Committee ("ARC"), which involved, in part, commissioning, reviewing, and then tracking implementation of several internal audits of procedures and controls at CI Arb headquarters each year. Those audits were focused on a diverse range of issues including risk management, data privacy, fraud prevention, cybersecurity, etc. The 2023 audit plan approved during my last meeting as ARC chair includes whistleblowing and staff performance procedures audits.

At the final board meeting of 2022 I was elected deputy chair of BoT as well as chair of the BoT's new Nominations Committee which will be conducting the search for and recommendation of candidates for the five new appointed trustee slots on BoT.

In those new roles, I am working daily with our new board chair, Marion Smith KC of London, and senior HQ staff.

**Strategic Issues.** Based on concerns which I have been raising, HQ has committed (a) to develop a formal volunteer management strategy (including recognition/ acknowledgment mechanisms and a bureaucracy reduction plan to reduce burden on our volunteers (including branch board members)), and (b) to overhaul the Chartered Arbitrator process to ensure that the necessarily high qualification standards are consistently applied and protected.

If you are asked to participate in a focus group zoom on either of those issues, please do make time, if possible. They are key parts of culture change efforts at headquarters.

The Institute's first-ever strategic plan is now in its 3rd and final year. Rather than begin the process of developing a new strategic plan, we have decided to take a year to analyze ways to better benchmark success by developing measurable metrics rather than simply relying on subjective staff impressions. We will pick a few elements of the old plan and focus on those in the coming year per newly developed benchmarks.

I have been advocating for a more systematic approach to reestablishing the Institute's reputation as an innovative "thought leader" in our sector, including by identifying and convening members with special expertise. Headquarters is forming advisory groups and launching new programs in areas such as technology in arbitration, climate change, and mixed mode ADR. If you are contacted or see a general invitation, please consider joining the effort.

**YMG.** Having formed one at NAB when I was chair, and having seen how dynamic and impactful it was, I am a big booster of the Institute's global Young Members Group ("YMG") program. (Thank you, Imad, for doing all the heavy lifting on forming the NAB YMG and serving as inaugural chair.) The BoT chair and I have worked to regularize the global YMG as a non-territorial "branch" of the Institute for budgeting, management, and policy purposes, which should increase its effectiveness and provide more support for branch YMGs.

**Member Value Proposition.** A major focus of BoT over the past two years has been on increasing the value of CI Arb membership. In addition to steps mentioned above, we have funded a long-overdue technology systems overhaul at headquarters which will simplify member-related processes, create more efficiencies in management (including for branches), and create enhanced marketing and substantive benefits for members. I monitored that work closely as ARC chair. We expect key elements of the plan to go live

this summer.

Among other initiatives, headquarters has been engaging successfully with arbitral institutions, a number of which now will accept the CI Arb Fellow qualification as prima facie evidence of the level of expertise required for such institution's panel of arbitrators.

## Inaugural Fellow *Emeritus* Award Presented to John W. Garman FCI Arb



The Chartered Institute of Arbitrators, North America Branch met in Santa Fe, New Mexico for the First Annual Members' Retreat from April 14-16, 2023. The CI Arb North America Branch belatedly bestowed its inaugural Fellow *Emeritus* award to **John W. Garman, FCI Arb**. John was awarded this distinction in 2021; however, due to the pandemic, an in-person bestowment of the inaugural award was postponed and presented by **Amb. (r.) David Huebner FCI Arb, C. Arb, Coll Arb**, Deputy Chair of CI Arb's Board of Trustees, Americas at the Santa Fe conference.

The North America Branch proudly recognized **John Garman** for his long and distinguished record of service to the branch including his stewardship of the branch for many years, as well as his tutelage and oversight of the intensive Accelerated Route to Fellowship courses during his tenure. **John** served on CI Arb-NAB's Executive Board (2010-2018), twice as Branch Chair (2015-2017) and was

responsible for organizing and overseeing multiple NAB programs and conference participations throughout the U.S. He organized training programs from 2011 through

John McArthur FCIARB and Northern California Chapter Chair has written a new, scholarly book, *The Reasoned Arbitration Award in the United States: Its Promise, Problems, Preparation, and Preservation*. John's book explains his view that that "silent" awards are not less prone to challenge and not necessarily cheaper to prepare than reasoned awards, criticizes six ways awards often fail to give meaningful reasons, and argues that U.S. courts have improperly tended to uphold such awards as "reasoned." The work has John's extensive analysis of each ground of vacatur and its success rate based on his study of vacatur opinions in Westlaw for 2010–2017 with a link to appendices with synopses of the vacatur opinions for exceeding powers, manifest disregard, violating public policy, and evident partiality. It also has appendices for awards he treats as well

reasoned and for those he views as not so. John spoke on awards at the NAB Members' Retreat in Santa Fe in April.

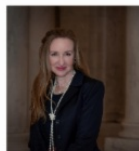
